ARPC, OEV Announces \$1M to Establish Revolving Loan Fund to Serve Businesses in Tallahassee-Leon County

TALLAHASSEE, Fla., October 15, 2020 – Today, the Apalachee Regional Planning Council (ARPC) and Office of Economic Vitality (OEV) are proud to announce the establishment of the Regional Economies Vested In Vital Enterprises (REVIVE!) program, a \$1 million Revolving Loan Fund (RLF) to assist businesses in Tallahassee-Leon County. This program was made possible by an \$800,000 grant to the ARPC by the U.S. Department of Commerce’s Economic Development Administration, matched with a \$200,000 investment by OEV.

The purpose of REVIVE! is aimed at stimulating long-term, private sector investment and employment in the Apalachee Region, and specifically, in Florida’s Capital. This program provides urgent capital needs to small businesses that have been underserved by either traditional lending institutions or other public funding programs. REVIVE! complements OEV’s efforts of economic inclusion, and creating and retaining permanent jobs, and ARPC’s efforts of improving the economic environment of the Apalachee Region.

ARPC Executive Director Chris Rietow said, “The REVIVE! revolving loan fund will be of great assistance to small businesses that may have been overlooked by traditional lending institutions. We’re proud to partner with the Economic Development Administration and OEV to leverage these funds to provide local enterprises with much-needed capital.”

The program comes at a crucial time as many local businesses and entrepreneurs are still dealing with the effects of the COVID-19 pandemic. The funds are intended to help establish new businesses and create employment opportunities or expand existing businesses and save existing jobs. To qualify for REVIVE!, a business must create or retain full-time, permanent jobs and be located in Tallahassee-Leon County.

“Our small businesses are critical to our local economy and OEV is pleased to provide matching funds to leverage the federal grant into the program so that businesses in Leon County have
